

Occupational Licensing Enforcement: Guidelines For The Investigator

SECTION 12. Section 74-471 of the Code of Ordinances of the City of Merriam, Kansas is hereby amended to read as follows:

Sec. 74-471. - Type I Home occupation use limitations.

In addition to the use limitations listed in Sec 74-469, Type I home occupation shall have the following additional use limitations.

- (1) One nonresident employee is allowed. A "nonresident employee" includes an employee, business partner, co-owner, or other person affiliated with the Type I home occupation who does not live at the dwelling but regularly routinely visits the site as part of the home occupation.
- (2) Only 10 customers-customer vehicles or clients may visit the dwelling unit in a day.
- (3) Except for group gatherings envisioned in Section 74-471 (4), No no more than three customers or clients can be present at the dwelling unit at the same time than can arrive at the residence in the vehicles for which off street parking is provided.
- (4) Group gatherings or meetings (involving more than one customer or client) may be held at the location of the home occupation no more frequently than one two times per month and shall be held inside the home occupation dwelling unit or its accessory structure. Parking for these events can occur in the right-of-way in areas where parking is not prohibited.
